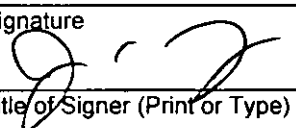

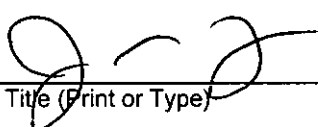

Exhibit A

Harbor Offshore Real Asset Fund, Ltd. (the "Fund") is a private investment fund formed to pool the assets of its investors for the purpose of investing in a wide variety of securities and other financial instruments. The Fund is offering Shares of beneficial interest on a continuous basis to qualified investors. Although there is no maximum or minimum aggregate amount of Shares which may be sold in this continuous offering, we have inserted the figure \$100,000,000 in Part C (1) of Form D as a reasonable estimate of the aggregate offering price of such Shares.
