



“Item C.1” of Form D

The Offering closed on April 10, 2007. The Issuer offered and sold 1,502,000 of its Units (the “Units”), each Unit consisting of one common share (“Share”) and one common share purchase warrant (“Warrant”), at a price of \$0.5338 USD [\$0.60 CDN] per Unit for a total aggregate offering amount of \$801,707.97 USD [\$901,200 CDN].

The Units were offered and sold outside the United States in accordance with Rule 903(b)(1) of Regulation S and within the United States in accordance with Rule 506 of Regulation D.

“Item C.2” of Form D

Of the total Units offered and sold in this Offering, 250,000 Units were sold in the United States by the Issuer for gross proceeds of \$133,440 US [\$150,000 CAD].

These offers and sales of Units were made in accordance with Rule 506 of Regulation D by certain officers and directors of the Issuer to “Accredited Investors,” as defined in Rule 501(a) of Regulation D, residing in the following state: Illinois.

No sales commissions or other selling-related remuneration were paid or given directly or indirectly to any officer or director of the Issuer for the offers and sales of Units made to the above-mentioned Accredited Investor residing in Illinois.

A finders fee of \$10,675 US [\$12,000 CAD] was paid in connection with the sale of 250,000 of the Units.
