





The aggregate offering amount of USD \$88,690.71 (Cdn. \$100,934) stated under Items C.1 and C.2 of this Form D filed under Rule 506 of Regulation D represents the estimated aggregate offering amount of the maximum number of 403,736 fully-paid and non-assessable common shares to be issued in accordance with the subscription agreement (the "Agreement").

The Agreement was accepted on February 27, 2007 by the above-referenced issuer and an "Accredited Investor" (as defined by Rule 501(a) of Regulation D) residing in Florida and accepted by the TSX Venture Exchange on February 27, 2007 (the "Approval Date").

The filing of this Form D under Rule 506 is intended to cover all issuances of fully-paid and non-assessable common shares made by the Issuer subject to the terms and conditions of the Agreement and any subsequent amendments thereto.

The issuer distributed 403,736 common shares under the terms of the Agreement and also distributed warrants convertible into common shares of 403,736 at the exercise price of \$0.30 per share in the first year and at \$0.40 per share during the second year.

The estimated offering amount of USD \$88,690.71 (Cdn. \$100,934) was derived by multiplying the subscription price of Cdn. \$0.25 and converted to U.S. dollars using the Bank of Canada noon rate of USD/CDN \$ 0.8787.
