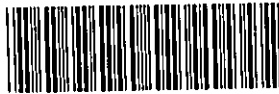

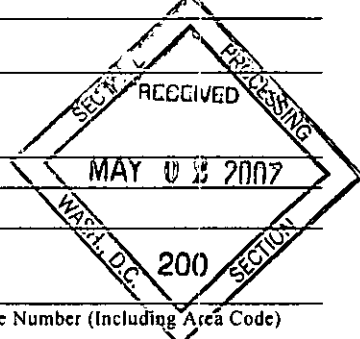

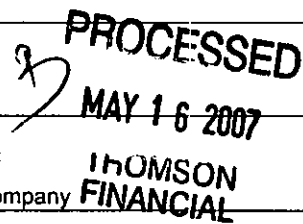

Exhibit to Form D of National Trench Safety, LLC

On April 17, 2007, National Trench Safety, LLC (the "Company") issued a warrant (the "Warrant") to purchase 2,250 Class A Units of the Company, with an exercise price of \$0.01 per Class A Unit, in favor of Laminar Direct Capital L.P., an accredited investor ("Laminar"), in connection with the execution and delivery of an Amended and Restated Credit Agreement by and among Laminar, the Company and a wholly-owned subsidiary of the Company. The Company did not receive any proceeds from the issuance of the Warrant.
