



Brief Description of Business To invest substantially all of its assets into 1861 Capital Offshore Fund Ltd., which in turn invests in 1861 Capital Master Fund LP, which will seek to generate attractive returns primarily through the trading of municipal bonds, the effective trading of residual certificates of tender option bond trusts backed by municipal bonds, and the effective trading of synthetic positions in municipal bonds, along with the use of various hedging and trading strategies.


