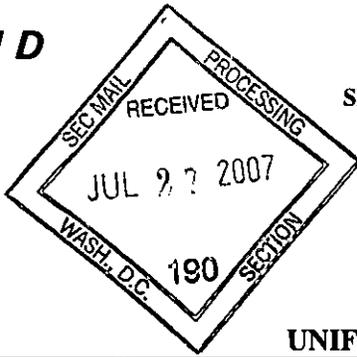

In this private placement (the "Offering") that closed on July 19, 2007, the Issuer and Canaccord Capital Corporation ("Canaccord"), BMO Nesbitt Burns Inc. ("BMO"), Toll Cross Securities Inc., Raymond James Ltd. and Haywood Securities Inc. (collectively, the "Agents") offered and sold 16,000,000 special warrants (the "Special Warrants") at a price of \$5.00 (US) per Special Warrant for total gross proceeds of \$80,000,000 (US) pursuant to the terms and subject to the conditions of an agency agreement dated as of July 19, 2007 (the Agency Agreement") between the Issuer and the Agents.
