

**VELOCITY OIL & GAS, INC. ("VELOCITY"), SOLD 115,000 UNITS, EACH CONSISTING OF ONE SHARE OF COMMON STOCK, ONE WARRANT TO PURCHASE ONE SHARE OF COMMON STOCK AT AN EXERCISE PRICE OF \$0.25 PER SHARE, AND ONE WARRANT TO PURCHASE ONE SHARE OF COMMON STOCK AT \$0.50 PER SHARE (EACH A "UNIT") AT \$0.10 PER UNIT, TO SIX (6) NON-ACCREDITED AND ONE (1) ACCREDITED INVESTOR FROM SEPTEMBER 2006 TO JUNE 2007. 
