



⁽¹⁾ The transaction described herein involves (i) Oxford Resources GP, LLC's acquisition of a portion of the interests in a surface coal mining business in return for the issuance of Membership Interests of Oxford Resources GP, LLC, which had an agreed value of \$392,000, and cash paid to the former owners of such interests, and (ii) the issuance of Membership Interests of Oxford Resources GP, LLC to AIM Oxford Holdings, LLC for \$728,000. Oxford Resources GP, LLC received no cash proceeds in connection with the issuance described in clause (i) in the preceding sentence.
