COBHAM SIGNS US\$700 MILLION ACQUISITION FINANCING FACILITY

Cobham plc ('Cobham') is pleased to announce that it has concluded a US\$700 million acquisition financing facility through to 30 June 2009. The new facility, together with existing cash resources, provides capacity to fund the recent acquisitions of SPARTA Inc, Sensors and Antenna Systems, Lansdale and S-TEC Corporation and leaves a further US\$800 million of available funding capacity for future acquisitions.

The facility has been provided by Barclays Capital, BNP Paribas, Dresdner Kleinwort and Royal Bank of Scotland. The overall cost of this new facility is in line with the average cost of Cobham's existing borrowing arrangements.

Warren Tucker, Cobham Chief Financial Officer, said:

"I am pleased that we have been able to secure an increase in our borrowing facilities at attractive rates. Acquisitions are an important part of Cobham's strategy and we have an active acquisition pipeline, a robust balance sheet and a further US\$800 million of available finance which positions us well to take advantage of growth opportunities, which meet our strict acquisition criteria, in addition to those already announced."
