

The Company's original application for exemption pursuant to Rule 12g3-2(b) was made on June 12, 2001.

The Company, together with The Bank of New York, as depositary, registered American Depositary Receipts (*ADRs*) under Form F-6 on December 10, 2001. Further, the Company filed notice of its change of name from M Cell Limited to MTN Group Limited on November 4, 2002 under Form 424B3. 
