A second subscriber converted a warrant to purchase common stock of UNA Holdings, Inc., Up-N-Atom, LLC's holding company, in exchange for 294,783 Common Units and \$900,000 of subordinated debt for 900,000 Series A Preferred Units. Finally, UNA Holdings, Inc. contributed substantially all of its assets and liabilities in exchange for 893,427 Series A Preferred Units and 1,144,771 Common Units.


