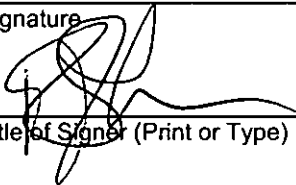

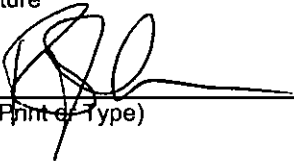

EXHIBIT A

Lucas Energy Ventures Fund I, LP ("Fund"), is a Delaware limited partnership organized for the purpose of maximizing net profits from the management of investments in the oil and gas industry, and to realize capital appreciation upon the ultimate sale of the investments. The Fund invests in oil and gas properties in North America, including directly and indirectly investing in ownership interests in (i) producing fields, (ii) producing fields with development potential, (iii) exploratory prospects, (iv) pipelines, (v) natural gas or oil processing facilities, (vi) geological, engineering and geophysical information, (vii) exploratory and development drilling, and (viii) other interests relating to oil and gas exploration, development or production. New partners are admitted at any time until the first anniversary of the initial closing of investments into the Fund. The Fund is seeking \$60,000,000 of investments, although it may accept lesser amounts.
