EXHIBIT A

Veda Multi-Strategy India Fund, LP ("Partnership") is a Delaware limited partnership organized for the purpose of investing substantially all of its assets in Veda Multi-Strategy India Master Fund, LP. The Partnership was organized to pool investment capital, and to allocate such capital among a number of separately managed accounts and/or investment funds (collectively, "Underlying Funds") that are managed or advised by independent third-party investment managers. The assets of the Partnership will be allocated to Underlying Funds which invest and trade in a wide variety of Indian securities and financial instruments, of all kinds and descriptions, whether publicly traded or privately placed, including but not limited to common and preferred stocks, real estate, bonds and other debt securities, convertible securities, limited partnership interests, mutual fund shares, options, warrants, commodities, futures, derivatives (including swaps, forward contracts and structured instruments), currencies, monetary instruments and cash and cash equivalents. The Partnership's minimum investment amount is \$500,000, although Veda Capital Partners, LLC ("General Partner") has discretion to accept lesser amounts. The limited partnership interests will be offered in the sole discretion of the General Partner. Although there is no maximum or minimum aggregate amount of the limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
