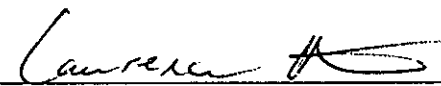

EXHIBIT A

The Covenant Advantage Fund, LLC ("Company") is a private investment company formed to pool investment funds of its investors (each a "Member" and, collectively, "Members," which term includes the Managing Member in such capacity) for the purpose of investing and trading in a wide variety of securities and financial instruments, domestic and foreign, primarily focusing on investing and trading in options. The Company is offering limited liability company interests on a continuous basis to qualified investors. Although there is no maximum or minimum aggregate amount of limited liability company interests which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited liability company interests.
