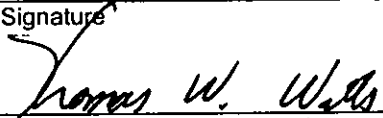

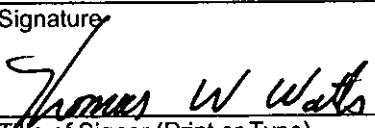

EXHIBIT A

Watts Performance Fund, LP ("Partnership") is a Delaware limited partnership organized for the purpose of investing and trading in a wide variety of securities and other financial investments, domestic and foreign. The Partnership's minimum investment amount is \$250,000, although Watts Performance Fund GP, LLC ("General Partner") has discretion to accept lesser amounts. The limited partnership interests will be continuously offered in the sole discretion of the General Partner. Although there is no maximum or minimum aggregate amount of limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
