* As set forth in the Confidential Private Offering Memorandum, the issuer and its pro rata share of the operating expenses of Chilton Pan-Asia Pacific, L.P. (the "Master Fund"). In addition, the Fund will pay the Managing General Partner a fixed fee computed at an annual rate of 1.5% of the net asset value of each Series of Class A Shares and Class B Shares and an annual rate of 1.75% of the net asset value of each Series of Class C Shares and Class D Shares payable by the Master Fund to Chilton quarterly in advance. This fixed fee will be paid quarterly and will be calculated based on the value of such Sub-Accounts at the beginning of such a fiscal quarter. The Managing General Partner will also receive a performance allocation equal to 20% of (i) the net profits allocated as of the end of each fiscal year and (ii) the date of redemption (with respect to shares redeemed), in each case, subject to the makeup of any loss carry forward.
