India Multi-Strategy Fund (C.I.) Limited is an exempted company incorporated with limited liability in the Cayman Islands as an open-ended investment vehicle (the "Fund"). The Fund is organised as a feeder fund and substantially all of the Fund's assets are invested in India Multi-Strategy Master Fund (C.I.) Limited, an exempted company incorporated with limited liability in the Cayman Islands (the "Master Fund"). The Company was formed to pool investment funds of its investors for the purpose of investing in the Master Fund. The Master Fund was formed for the purpose of achieving broad participation in India's long-term economic growth while limiting downside risks by looking for attractive investment and trading opportunities across all asset classes related to India. The Fund's minimum investment amount is \$1,000,000, although the Fund has discretion to accept lesser amounts. The interests will be continuously offered in the sole discretion of the Fund. Although there is no maximum aggregate amount of shares which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such shares.
