

⁽¹⁾ The transaction described herein involves (i) Tunnel Hill Partners, LP's acquisition of a portion of the interests in a landfill operations business in return for the issuance of Class B-2 Units of Tunnel Hill Partners, LP, which had an agreed value of \$12,037,246.15, and cash paid to the former owners of such interests, and (ii) the issuance of Class B-1 Units of Tunnel Hill Partners, LP to AIM Tunnel Hill Holdings II, LLC, which had an agreed value of \$25,205,600.00, for an additional portion of the interests in such landfill operations business along with a \$7,359,046.15 capital contribution in cash. Tunnel Hill Partners, LP received no cash proceeds in connection with the issuance described in clause (i) in the preceding sentence.
