1/ This Offering is in connection with the acquisition of all of the issued and outstanding capital stock of another entity. 1,250,000 shares of Class A Common Stock of the issuer were initially issued in exchange for the acquisition of all of the issued and outstanding capital stock (\$1,500,000 of the total \$6,285,000 purchase price was paid in the form of Class A Common Stock of the issuer and the balance in cash; \$785,000 cash is being held in escrow) (additional consideration of up to a maximum of \$6,855,000 to be paid to the same sellers, in the form of cash and Class A Common Stock, subject to certain post-closing earnout provisions). In connection with the first earnout, 828,166 shares of Class A Common Stock of the issuer were issued as additional consideration (\$1,035,207.50 of the total \$2,285,000.02 additional consideration was paid in the form of Class A Common Stock of the issuer and the balance in cash). In connection with the second and third earnouts, 1,055,765 shares of Class A Common Stock of the issuer were issued as additional consideration (\$1,790,912 of the total \$4,570,000 additional consideration was paid in the form of Class A Common Stock of the issuer and the balance in cash).

The total number of shares issued and outstanding to date in connection with these Offerings is 3,133,931 shares of Class A Common Stock.


