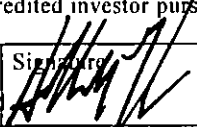

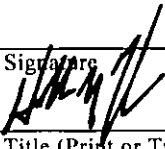

**UNITED DEVELOPMENT FUNDING LAND
OPPORTUNITY FUND INVESTORS, LLC**

Part A, Item 1. – United Development Funding Land Opportunity Fund Investors, LLC (the "Blocker Fund") will purchase up to 24.9% of the Limited Partnership Interests of United Development Funding Land Opportunity Fund, L.P., a Delaware limited partnership (the "Opportunity Fund"), for the purposes of allowing certain benefit plan investors the opportunity to invest in the Limited Partnership Interests indirectly and avoid unrelated business taxable income and other tax aspects that may be adverse to such investors and that result from a direct investment. The Blocker Fund will have no operations or assets other than its investment in the Opportunity Fund, which has simultaneously filed a Form D to register its concurrent offering and sale of Limited Partnership Interests.
