EXHIBIT A

Advantage Capital Real Estate Opportunities Fund, LP ("Partnership") is a limited partnership that was formed to pool investment funds of its investors for the purpose of making strategic investments and acquisitions in asset backed loans and real property. The Partnership's minimum investment amount is \$250,000, although Advantage Capital Equity Solutions (FL), Inc. ("General Partner") has discretion to accept lesser amounts. The limited partnership interests will be offered in the sole discretion of the General Partner. Although there is no maximum or minimum aggregate amount of the limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
