EXHIBIT A

JES Partners Fund, LP ("Partnership") is a Delaware limited partnership. The Partnership was formed to pool investment funds of its investors and to invest such funds in collective investment vehicles and managed accounts that are managed by a number of independent portfolio managers. The Partnership's minimum investment amount is \$250,000, although JES Administrative Services LLC ("General Partner") has discretion to accept lesser amounts. The limited partner interests will be continuously offered in the sole discretion of the General Partner. Although there is no maximum or minimum aggregate amount of limited partners interests which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
