## EXHIBIT A

Aquila Technology Opportunities Fund, LP (the "Partnership") is a Delaware limited partnership. The Partnership was organized for the purpose of investing and trading in a wide variety of U.S. and non-U.S. securities and financial instruments of all kinds and descriptions, whether publicly traded or privately placed, including, but not limited to, common and preferred stocks, bonds and other debt securities, convertible securities, limited partner interests, mutual fund shares, options, warrants, commodities, futures, derivatives (including swaps, forward contracts and structured instruments), currencies, monetary instruments and cash and cash equivalents. The Partnership's minimum investment amount is \$500,000, although Celestial Advisors GP I, LLC, a Delaware Limited Liability Company (the "General Partner") has discretion to accept lesser amounts. The limited partner interests will be offered in the sole discretion of the General Partner. Although there is no maximum or minimum aggregate amount of the limited partner interests which may be sold in this continuous offering, we have inserted the figure of \$200,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partner interests.
