


We have just learned that the SEC needs us to complete a Form TA-W to officially indicate that OneSource Services, Inc. is no longer serving as a Registered Agent. We discontinued our duties as a Registered Agent in December of 2005.

I have reviewed our records and find that we filed a TA-1 amendment on December 14, 2005 indicating that we were no longer engaged as a Registered Agent, as we had terminated our engagement with the only client for which we provided these services. In our conversations with the SEC at that time we were informed that we had to file a final TA-2 for the year ended 2005, which we filed on January 31, 2006. We did not file a TA-W at that time. We were also told by your agents to write a letter of notification of our desire to terminate all Transfer activities. I have enclosed a copy of this letter dated January 23, 2006 for your review.
