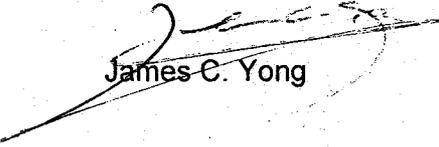
Dear Ms. Jackson:
