1. Organization and Nature of Business

Wolfensohn Advisors, L.L.C. (the "Company") (a development stage company) was organized on February 16, 2007 under the laws of the State of New York. The Company is a registered broker-dealer pursuant to section 15(b) of the Securities Exchange Act of 1934. On September 21, 2007, the Company became a member of the Financial Industry Regulatory Authority.

The Company has been in the development stage since its formation on February 16, 2007. The Company will engage in merger and acquisition transactions.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Income Taxes

As a limited liability company, the Company is not liable for federal or state income taxes. Each member is responsible to report separately his distributive share of Company income or loss to tax authorities. The Company is, however, subject to the New York City unincorporated business tax.

Deferred tax assets and liabilities are recognized for the future tax consequences attributable to differences between the financial statement carrying amounts of existing assets and liabilities and their respective tax bases. Deferred tax assets are reduced by a valuation allowance when, in the opinion of management, it is more likely than not that some portion or all of the deferred tax assets will not be realized.

Working Capital Contributions

The members intend to continue to provide working capital to meet operational and regulatory requirements.

3. Related Party

A related party owned by the Company's members entered into an administrative service agreement whereby expenses incurred on behalf of the Company will be paid by the related party and reimbursed by the Company. This agreement provides for administrative support, rent, telecommunication and other general services to be allocated in accordance with the agreement. During the period September 21, 2007 to December 31, 2008, the Company was charged approximately \$18,500 for these expenses.

4. Net Capital Requirements

The Company is subject to the uniform net capital requirements of Rule 15c3-1 of the Securities and Exchange Commission, which requires a broker-dealer to have, at all times, sufficient liquid assets to cover current indebtedness. In accordance with the rule, the Company is required to maintain defined minimum net capital to the greater of \$5,000 or 1/15 of aggregate indebtedness as defined. At no time may the ratio of aggregate indebtedness to net capital exceed 15 to 1.

At December 31, 2008, the Company had net capital, as defined, of \$15,690 which was \$10,690 in excess of its required net capital of \$5,000. Aggregate indebtedness at December 31, 2008 was \$24,326. The ratio of aggregate indebtedness to net capital was 1.55 to 1

Income Taxes

Deferred income taxes reflect the tax effects of (a) temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the amounts used for income tax purposes, and (b) operating loss and tax credit carryforwards.

The Company has a deferred tax asset of approximately \$ 2,000 as of December 31, 2008 as a result of unused net operating loss carryforwards. A full valuation allowance of approximately \$2,000 was established at December 31, 2008 to eliminate the deferred tax benefit due to the uncertainty of the realization of the tax benefit.

The valuation allowance increased approximately \$2,000 during the period September 21, 2007 to December 31, 2008.

At December 31, 2008, the Company's available unused net operating losses that may be applied against future taxable income will expire as follows:


Independent Auditors' Report
