**REPORT OF INDEPENDENT REGISTERED PUBLIC ACCOUNTING FIRM

Compared the total revenue amounts of the audited Form X-17A-5 for the year ended December 31, 2009 less revenues reported on the FOCUS reports for the period from January 1, 2009 to March 31, 2009, as applicable, with the amounts reported in Form SIPC-7T for the period from April 1, 2009 to December 31, 2009 noting no differences;
3. Compared any adjustments reported in Form SIPC-7T with supporting schedules and working papers, including general ledger detail reports, trial balances, and a schedule of underwriting expenses and related invoice support, noting no differences;
4. Proved the arithmetical accuracy of the calculations reflected in Form SIPC-7T and in the related schedules and working papers, including general ledger detail reports, trial balances, and a schedule of underwriting expenses and related invoice support, supporting the adjustments noting no differences.
