

Report on the Financial Statements

We have audited the accompanying statement of financial condition of ICON Distributors, Inc. (the "Company") as of December 31, 2012 and the related statements of operations, changes in shareholder's equity and cash flows for the year then ended that are filed pursuant to Rule 17a-5 under the Securities Exchange Act of 1934 and the related notes to the financial statements.

Management's Responsibility for the Financial Statements
