

  - (b) any civil suit or action brought against the Filer or to which the Filer has been joined as defendant or respondent, in any appropriate court in any place subject to the jurisdiction of any state or of the United States, or of any of its territories or possessions, or of the District of Columbia, where the investigation, proceeding or cause of action arises out of or relates to or concerns any offering made or purported to be made in connection with the rights offering or qualified by the Filer on Form CB on June 20, 2016, as such form may be amended from time to time after the date hereof, or any purchases or sales of any security in connection therewith.
