Opinion on the Financial Statements

We have audited the accompanying statement of financial condition of Vision 4 Fund Distributors, LLC as of December 31, 2022, the related statements of income, changes in member's equity, and cash flows for the year then ended, and the related notes and schedules (collectively referred to as the "financial statements"). In our opinion, the financial statements present fairly, in all material respects, the financial position of Vision 4 Fund Distributors, LLC as of December 31, 2022, and the results of its operations and its cash flows for the year then ended in conformity with accounting principles generally accepted in the United States of America.

Basis for Opinion

These financial statements are the responsibility of Vision 4 Fund Distributors, LLC's management. Our responsibility is to express an opinion on Vision 4 Fund Distributors, LLC's financial statements based on our audit. We are a public accounting firm registered with the Public Company Accounting Oversight Board (United States) (PCAOB) and are required to be independent with respect to Vision 4 Fund Distributors, LLC in accordance with the U.S. federal securities laws and the applicable rules and regulations of the Securities and Exchange Commission and the PCAOB.

Note 1 – Nature of Business and Significant Accounting Policies

Nature of Business

Vision 4 Fund Distributors, LLC (the “Company”) is a broker-dealer registered with the Securities and Exchange Commission (“SEC”) and is a member of the Financial Industry Regulatory Authority (“FINRA”) and the Securities Investors Protection Corporation (“SIPC”). Vision 4 Fund Distributors, LLC is a limited liability company organized under the laws of the State of Delaware.

The Company is approved to conduct business in the wholesaling of mutual funds and providing referral activities. The Company does not execute or clear securities transactions nor maintains any customer accounts.

Under its membership agreement with FINRA and pursuant to Rule 15c3-3, in reliance on footnote 74 to SEC Release Number 34-70073 dated July 30, 2013, the Company is exempt from Rule 15c3-3 as it does not hold customer funds or securities.

Basis of Accounting

The books of the Company are maintained on the accrual basis of accounting, whereby revenues are recognized when they are earned and expenses are recognized when they are incurred.

Use of Estimates

The presentation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Cash and Cash Equivalents

For the year ending December 31, 2022, the Company has maintained six bank accounts and has no investments in securities.

Accounts Receivable

Accounts receivable represents amounts that have been earned and have been billed to clients in accordance with the term of the Company’s engagement letters with respective clients that have not yet been collected. As of December 31, 2022, the Company considered 100% of the receivables to be collectible, therefore no allowance was necessary.

Revenue

For the year ended December 31, 2022, the Company posted \$304,573 in net losses. The Company has generated \$4,419,333 in revenue from wholesaling and referral activities and an additional \$8,739 in interest revenue. The Company markets mutual funds registered under the Investment Company Act of 1940 to financial institutions and their agents on behalf of registered investment advisers who serve as investment advisers to the mutual funds marketed. In return for services, the Company receives as revenue commissions, a percentage of assets of the mutual fund(s) and/or a percentage of the amount cumulatively raised by other financial institutions. The commission income is recognized at the end of each month after mutual funds have been traded and managed. The Company did not receive fees for services not yet provided and consequently has no deferred revenue at year end.

Expenses

For the year ended December 31, 2022, the Company has posted \$4,732,645 in total expenses. Primary contributors to expenses include employee compensation and benefits; travel and meals; technology expenditures, and professional fees.

Income Taxes

The firm elected in 2018, pursuant to the filing of a Form 8832 with the Internal Revenue Service, to be taxed as a corporation for federal income tax purposes. An income tax liability of \$24,265 has been included in the financial statements for the fiscal year ending December 31, 2022. Cumulative, state income tax payments during the year were \$800. No federal income tax payments were made.

Management has determined that the Company does not have any uncertain tax positions and associated unrecognized benefits that materially impact the financial statements or related disclosures. Since tax matters are subject to some degree of uncertainty, there can be no assurance that the Company's tax returns will not be challenged by the taxing authorities and that the Company or its members will not be subject to additional tax, penalties, and interest as a result of such challenge. The Company's and members' income tax returns are subject to examination by taxing authorities for a period of three years from the date they are filed.

Note 2 – Related Party Transactions – Expense Sharing Agreement

The Company entered into an expense sharing agreement with ResQ Investment Partners, LLC for the allocation of expenses. ResQ Investment Partners, LLC is a registered investment adviser that has common ownership and control that shares some expenses with the Company. The current expense sharing agreement, dated August 15, 2022 requires reimbursement of expenses between Vision 4 Fund Distributors, LLC and ResQ Investment Partners, LLC for expenses incurred by the other party for which both parties share in such services and/or assets. Vision 4 Fund Distributors, LLC reimburses ResQ Investment Partners, LLC at fifty percent (50%) of costs for internet expenses and fees associated with the administration of the 401k plan. ResQ Investment Partners, LLC reimburses Vision 4 Fund Distributors for actual costs incurred by Vision 4 Fund Distributors, LLC pertaining to employees of ResQ Investment Partners, LLC relating to medical, dental, and vision insurance; cybersecurity expenses associated with dedicated ResQ Investment Partners, LLC computers; and for any employee contributions and employer matches/contributions to 401k plans paid by Vision 4 Fund Distributors, LLC on behalf of ResQ Investment Partners, LLC employees. At December 31, 2022, ResQ Investment Partners, LLC owed Vision 4 Fund Distributors, LLC \$23,870 for incurred ResQ expenses that Vision 4 Fund Distributors, LLC paid for in prior years.

Note 3 – Prior Period Adjustments - Member's Equity

For the year ended December 31, 2022, total member's equity increased from the reported member's equity of \$455,454 on the previous year's annual audit report to \$714,420. This increase is due to adjustments made to 2020 and 2021 financial statements to reflect as receivables employee retention credits cumulatively totaling \$595,039 due to Vision 4 Fund Distributors, LLC from the United States Treasury Department minus a net loss of \$304,573.

Note 4 – Net Capital Requirements

The Company is subject to the Securities and Exchange Commission Uniform Net Capital Rule ("SEC Rule 15c3-1"), which requires the maintenance of a minimum net capital and requires that the ratio of aggregate indebtedness to net capital, both as defined, shall not exceed 15 to 1. At December 31, 2022, the Company had net capital of \$427,464 which was \$422,464 in excess of its required net capital of \$5,000. The Company's aggregate indebtedness requirement was \$2,080.

Note 5 – Concentrations of Credit Risk And Other Business Concentrations

The Company does not carry accounts for customers or perform custodial functions related to customers' securities. The Company's policy is to maintain its cash balances in reputable financial institutions insured by the Federal Deposit Insurance Corporation ("FDIC"), which as of December 31, 2022 provided \$250,000 of insurance coverage on deposit accounts. At December 31, 2022, the Company maintained one account whose balance of \$215,680 was in excess of the \$250,000 in insurance coverage.

Note 6 – Employee Retention Credit

In 2022, Vision 4 Fund Distributors, LLC sought to benefit from the Employee Retention Credit Program under the CARES Act offered by the United States government. The program allows employers to receive money back in paid taxes for retaining employees. The firm filed Form 941-X (Adjusted Employer's Federal Tax Return or Claim of Refund) for the periods covering Quarter 4 2020 through Quarter 3 2021. As the government has indicated that any amounts to be received shall be reported as income in the year of the Form 941-X as opposed to the year in which it was filed or payment was received, the firm amended its financial statements in 2020 and 2021 to record revenue and a receivable of the calculated amount due to Vision 4 Fund Distributors, LLC. The firm posted \$43,995 and \$551,045 as receivables in 2020 and 2021. As of December 31, 2022, Vision 4 Fund Distributors, LLC had a receivable of \$193,338 as the firm had received refunds covering the period of Quarter 4 2020 through Quarter 3 2021.

Note 7 –Subsequent Events

In preparing these financial statements, the Company has evaluated events and transactions for potential recognition or disclosure on the financial statements of the Company at December 31, 2022 through the date of the report of independent registered public accounting firm. There are no such events to report.

We have reviewed management's statements, included in the accompanying Exemption Report, in which (1) Vision 4 Fund Distributors, LLC identified the following provisions of 17 C.F.R. §15c3-3(k) under which Vision 4 Fund Distributors, LLC does not claim an exemption under paragraph (k) of 17 C.F.R. §240.15c3-3; and (2) the Company is filing this Exemption Report relying on Footnote 74 of the SEC Release No. 34-70073 adopting amendments to 17 C.F.R. §240.17a-5 because the Company limits its business activities to wholesaling mutual funds and the Company (1) did not directly or indirectly receive, hold, or otherwise owe funds or securities for or to customers, (other than money or other consideration received and promptly transmitted in compliance with paragraph (a) or (b)(2) of Rule 15c2-4 and/or funds received and promptly transmitted for effecting transactions via subscriptions on a subscription way basis where the funds are payable to the issuer or its agent and not to the Company); (2) did not carry accounts of or for customers; and (3) did not carry PAB accounts (as defined in Rule 15c3-3) throughout the most recent fiscal year without exception.

Our review was conducted in accordance with the standards of the Public Company Accounting Oversight Board (United States) and, accordingly, included inquiries and other required procedures to obtain evidence about Vision 4 Fund Distributors, LLC's claim to limiting its business activities to wholesaling mutual funds and that the Company (1) did not directly or indirectly receive, hold, or otherwise owe funds or securities for or to customers; (2) did not carry accounts of or for customers; and (3) did not carry PAB accounts (as defined in Rule 15c3-3) throughout the most recent fiscal year without exception.

A review is substantially less in scope than an examination, the objective of which is the expression of an opinion on management's statements. Accordingly, we do not express such an opinion.

Based on our review, we are not aware of any material modifications that should be made to management's statements referred to above for them to be fairly stated, in all material respects, based upon the Company's business activities contemplated by Footnote 74 of the SEC Release No. 34-70073 adopting amendments to 17 C.F.R. § 240.17a-5, and related SEC Staff Frequently Asked Questions.
