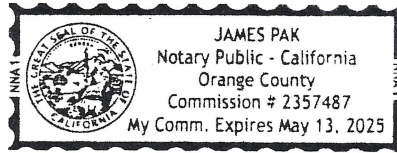

**Opinion on the Financial Statements**

**Basis for Opinion**
