**NOTE 1 - ORGANIZATION**

Foreside Global Services, LLC (the “Company”), a limited liability company, is an indirect, wholly-owned subsidiary of Foreside Financial Group, LLC (“Foreside”) and a direct subsidiary of Foreside Distributors, LLC (the “Parent”). The Company is registered with the Securities and Exchange Commission (“SEC”) as a broker-dealer and is a member of both the Financial Industry Regulatory Authority (“FINRA”) and the Securities Investor Protection Corporation (“SIPC”).

The limited liability company operating agreement provides for the Company to exist into perpetuity.

The Company provides chaperoning services for non-U.S. asset managers. In accordance with Rule 15a-6, such services include physically chaperoning, being copied on and reviewing any written communications and participating on phone calls between Foreign Associated Persons and U.S. Institutional Investors. Services also include reviewing all marketing materials provided to U.S. Institutional Investors and maintaining certain information, consents and applicable records.

The Company has identified the President as the chief operating decision maker, who uses net income to evaluate the results of the business, predominantly in the forecasting process, to manage the Company. Additionally, the chief operating decision maker uses excess net capital, which is not a measure of profit and loss, to make operational decisions while maintaining capital adequacy, such as whether to reinvest profits or pay distributions. The Company’s operations constitute a single operating segment and therefore, a single reportable segment, because the chief operating decision maker manages the business activities using information of the Company as a whole. The measure of segment assets is reported on the Statement of Financial Condition as total assets. Information about the Company’s major clients is disclosed in the Concentrations footnote.

The accompanying financial statement has been prepared from the separate records maintained by the Company and, due to certain transactions and agreements with affiliated entities, may not necessarily be indicative of the financial condition that would have existed, had the Company operated as an unaffiliated entity.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***USE OF ESTIMATES***

The preparation of the financial statement in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and disclosures of contingent assets and liabilities at the date of the financial statement. Actual results could differ from those amounts.

***CASH EQUIVALENTS***

The Company considers all highly liquid temporary cash investments with an original maturity of three months or less when purchased to be cash equivalents.

At December 31, 2024, the Company had no cash equivalents.

***RECEIVABLES***

The Company extends unsecured credit in the normal course of business to its clients. The Company accounts for estimated credit losses on financial assets measured at an amortized cost basis in accordance with Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 326-20, *Financial Instruments – Credit Losses*. FASB ASC 326-20 requires the Company to estimate expected credit losses over the life of its financial assets as of the reporting date based on relevant information about past events, current conditions, and reasonable and supportable forecasts. The Company records the estimate of expected credit losses as an allowance for credit losses. For financial assets measured at an amortized cost basis, the allowance for credit losses is reported as a valuation account on the balance sheet that adjusts the asset’s amortized cost basis. Changes in the allowance for credit losses are reported as credit loss expense in earnings. As of December 31, 2024, the Company did not have an allowance for credit losses established since, based on the Company’s analysis, the Company does not expect any credit losses over the life of its financial assets. Past due accounts are written off by management when deemed uncollectible on a case-by-case basis.

***INCOME TAXES***

The Company is organized as a limited liability company (“LLC”) with Foreside as the only member, and as a single member LLC is treated as a disregarded entity under the Internal Revenue Code. As such, income, losses, and other tax attributes are primarily passed through to Foreside. Foreside is organized as an LLC that has elected to be treated as a corporation under the Internal Revenue Code. As such, income, losses, and other tax attributes are taxed at the entity level.

**NOTE 3 - RELATED PARTY TRANSACTIONS**

The financial statement has been prepared from the separate records maintained by the Company. The Company shares office space and equipment with affiliates, which are under common control of Foreside. Accordingly, the Company has been allocated a portion of such shared costs. Also, the Parent provides administrative, legal, human resource and other general support services, the costs of which are allocated to the Company. During the year ended December 31, 2024, these allocated expenses totaled \$830,217. At December 31, 2024, amounts due to the Parent totaled \$79,492, which is included in “Due to related parties” in the Statement of Financial Condition.

At December 31, 2024, “Due to related parties” also included \$34,130, which resulted from expenses paid on behalf of the Company by its affiliates.

The Parent agrees to financially assist the Company and is committed to provide such funds, as needed, to operate the business.

During the year ended December 31, 2024, the Company made capital distributions to the Parent totaling \$150,000.

**NOTE 4 - NET CAPITAL REQUIREMENT**

The Company is subject to the SEC's Uniform Net Capital Rule 15c3-1 (the “Rule”), which requires the maintenance of a minimum net capital amount. The Company has elected to use the alternative net capital method permitted by the Rule, which requires that the Company maintain a minimum net capital requirement of the greater of \$250,000 or 2% of aggregate debit items. At December 31, 2024, the Company had net capital of \$389,661, which was \$139,661 in excess of its minimum required net capital of \$250,000.

**NOTE 5 - COMMITMENTS AND CONTINGENCIES**

***INDEMNIFICATIONS***

The Company provides representations and warranties to counterparties in connection with a variety of commercial transactions and occasionally indemnifies them against potential losses caused by the breach of those representations and warranties. These indemnifications generally are standard contractual terms and are entered into in the normal course of business. The Company’s maximum exposure under these arrangements cannot be known; however, the Company expects any risk of loss to be remote.

**NOTE 5 - COMMITMENTS AND CONTINGENCIES (CONTINUED)**

***CREDIT RISK***

The Company maintains a checking account in a financial institution. The account is insured by the Federal Deposit Insurance Corporation (“FDIC”). At times, cash may be uninsured or in deposit accounts that exceed the FDIC insurance limit. The Company has not experienced any losses in the account. The Company believes it is not exposed to any significant risk on cash. Management periodically assesses the financial condition of the bank and believes that any potential credit loss is minimal.

***LITIGATION***

In the normal course of business, the Company may be involved in legal proceedings, claims and assessments arising from the ordinary course of business. Such matters are subject to many uncertainties, and outcomes are not predictable with assurance.

**NOTE 6 - CONCENTRATIONS**

As of December 31, 2024, two clients accounted for approximately 28% of service fee accounts receivable due from clients which are included in “Other receivables” in the accompanying Statement of Financial Condition.

**NOTE 7 - SUBSEQUENT EVENTS**

Management has evaluated the impact of all events and transactions occurring after the balance sheet date through the date this financial statement was issued, and has determined that there were no subsequent
