PRELIMINARY DETERMINATION OF THE CLAIMS REVIEW STAFF

In response to the above-referenced Notice of Covered Action, the Securities and Exchange Commission (the “Commission”) received a whistleblower award claim (“Form WB-APP”). Claimant’s information is not “original information” because it was not submitted after July 21, 2010, as required by Rule 21F-4(b)(1)(iv) of the Exchange Act.
