Dear Ms. Murphy,

I am an investor.

I strongly support regulations that would require publicly traded companies to disclose CEO-to-median worker pay ratios. As income inequality reaches unprecedented heights, the public has the right to know which corporations are fueling the yawning gap between rich and poor.

Disclosure of CEO-to-worker pay ratios are also crucial for investors. This information is important for determining whether corporations are diverting resources to executives at the expense of long-term investments and workforce development. Additionally, investors need to be able to gauge whether executives' compensation is falling in line with their performance.

In the absence of these facts the public and investors lack the pertinent detail, especially the comparative trends over several years, to know whether these corporations' leaders are truly effective relative to their industry peers, or merely lining their pockets for a big payday and a hasty exit.
