Dear Mr. Fields:

On October 3, 2018, Cboe BZX Exchange, Inc. (the “Exchange”) filed with the Securities and Exchange Commission (the “Commission”) Partial Amendment No. 4 to SR-CboeBZX-2018-047 in order to clarify certain points and add additional details. Partial Amendment No. 4 to SR-CboeBZX-2018-047 partially amends Amendment No. 2 to SR-CboeBZX-2018-047, which was filed on September 24, 2018, which amended and replaced in its entirety Amendment No. 1 to the proposal, which amended and replaced in its entirety the proposal as originally submitted on June 21, 2018. The Exchange submitted proposal SR-CboeBZX-2018-047 in order to amend its listing rules in Rule 14.8, General Listing Requirements - Tier I, in order to add listing standards applicable to Closed-End Funds. In order to provide notice for public review of this Partial Amendment No. 4, in addition to posting on the Exchange’s public website, the Exchange is filing this comment letter with the Commission.

**Partial Amendment No. 4 to SR-CboeBZX-2018-047**

Cboe BZX Exchange, Inc. (the “Exchange” or “BZX”) is filing this Partial Amendment No. 4 to SR-CboeBZX-2018-047, which was originally submitted on June 21, 2017 and subsequently amended and replaced in its entirety by Amendment No. 1, which was submitted on August 28, 2018, which was subsequently amended and replaced in its entirety by Amendment No. 2 (the “Proposal”), which was submitted on September 24, 2018. Pursuant to the Proposal, the Exchange proposed a rule change to amend its listing rules in Rule 14.8, General Listing Requirements - Tier I, in order to add listing standards applicable to Closed-End Funds. This Partial Amendment No. 4 proposes to add clarifying information related to details about the Proposal. The Exchange believes that these proposed changes clarify and add additional detail to the Proposal, as further described below, and are consistent with the Securities Exchange Act of 1934 in that they would further clarify and add additional detail to the Proposal.

The Exchange is proposing to change the reference to “unit of account” to instead say “unit of count” in footnote 9 of both the Form 19b-4 Information and the Exhibit 1 in

The Exchange is also proposing to change the text in footnote 16 in both the Form 19b-4 Information and the Exhibit 1 such that instead of saying “See supra note 9,” footnote 16 would say “See supra note 12.”

As noted above, the Exchange believes that these proposed changes add clarifying information related to details about the Fund and are consistent with the Securities Exchange Act of 1934 in that they would clarify and add additional detail to the Proposal and eliminate potential confusion.
