COMMENTS BY JANICE S. LINTZ: PURPOSE: THE DIVERSITY IMPER-ATIVE FOR CORPORATE BOARDS

January 25, 2021

ISSUE TOPIC:

Nasdaq should add disability to its diversity categories for company boards.

DISCUSSION:

Nasdaq proposes that each of its listed companies, subject to certain exceptions, (i) provide statistical information regarding diversity among the members of the company's board of directors under proposed Rule 5606 and (ii) have, or explain why it does not have, at least two "Diverse" directors on its board under proposed rule 5605(f)(2). "Diverse" means a director who self-identifies as (i) Female, (ii) an Underrepresented Minority, or (iii) LGBTQ+. Nasdaq fails to list disability as a specific category, despite the fact that the Americans with Disabilities Act was passed to recognize the discrimination that people with disabilities face.

People with a wide variety of disabilities are qualified; however, companies don't make efforts to recruit them and are often not given the opportunity to serve. I am CEO of a company promoting disability inclusion and have an auditory processing disability, the same learning disability that poet Aman-

da Gorman has. As my bio below indicates, people with disabilities, including myself, are fully capable of serving on a board.
