SR-NYSEArca-2015-42; Amendment No. 2

NYSE Arca, Inc. (“Exchange”) hereby amends SR-NYSEArca-2015-42 as amended by Amendment No. 1 (the “Filing”) as follows:

1. Footnote 14 on page 8 of the Filing and footnote 15 on page 32 of Exhibit 1 to the Filing are deleted and are replaced with the following:

“The Adviser expects that under normal market conditions, the Fund will seek to invest at least 75% of its corporate bond assets in issuances that have at least \$100,000,000 par amount outstanding in developed countries or at least \$200,000,000 par amount outstanding in emerging market countries.”

The Exchange believes that the proposed rule change, as modified by this amendment, is consistent with the requirement of Section 6(b)(5) of the Securities Exchange Act of 1934¹ (“Act”) that an exchange have rules that are designed, among other things, to prevent fraudulent and manipulative acts and practices, to promote just and equitable principles of trade, to remove impediments to, and perfect the mechanism of a free and open market and, in general to protect investors and the public interest. The proposed rule change changes “and” to “or” in the cited footnote, thereby clarifying that the \$100,000,000 and \$200,000,000 par amount outstanding criteria apply alternatively to issuances in developed countries and emerging market countries, respectively.

All other representations in the Filing remain as stated therein and no other changes are being made.
