SR-NYSEArca-2015-44; Amendment No. 3

NYSE Arca, Inc. (“Exchange”) hereby amends SR-NYSEArca-2015-44 as amended by Amendments No. 1 and No. 2 (the “Filing”) as follows:

1. The first full sentence in the first partial paragraph on page 10 of the Filing and the first full sentence in the first partial paragraph on page 38 of Exhibit 1 of the Filing are deleted and replaced with the following:

“In addition to the ETPs that are primary investments, the Portfolio may invest in other equity, including exchange listed or over-the-counter (“OTC”) common stock and preferred securities of domestic and foreign corporations, and fixed income securities.”

The Exchange believes that the proposed rule change, as modified by this amendment, is consistent with the requirement of Section 6(b)(5) of the Securities Exchange Act of 1934¹ (“Act”) that an exchange have rules that are designed, among other things, to prevent fraudulent and manipulative acts and practices, to promote just and equitable principles of trade, to remove impediments to, and perfect the mechanism of a free and open market and, in general to protect investors and the public interest. The proposed amendment clarifies that the equity that the Portfolio may invest in as part of its non-principal investments is in addition to the ETPs that the Portfolio may invest in as part of its principal investments.

All other representations in the Filing remain as stated therein and no other changes are being made.
