**SR-NYSEArca-2016-08; Partial Amendment No. 1**

NYSE Arca, Inc. (“Exchange”) hereby amends SR-NYSEArca-2016-08 (the “Filing”) as follows:

1. Footnote 11 on pages 12-13 of the Filing and footnote 12 on page 54 of Exhibit 1 to the Filing are deleted and replaced with the following:

“The Trust is registered under the 1940 Act. On January 22, 2014, the Trust filed a registration statement on Form N-1A under the Securities Act of 1933 (the "1933 Act") (15 U.S.C. 77a), and under the 1940 Act relating to the ActiveShares Large-Cap Fund, ActiveShares Mid-Cap Fund, and ActiveShares Multi-Cap Fund (File Nos. 333-171987 and 811-22524) (the "Registration Statement"), which funds would be replaced by the Precidian U.S. Large Cap Growth, Precidian U.S. Mid Cap Growth and Precidian Focused Dividend Strategy, as described below. The Trust will file an amendment to the Registration Statement prior to commencement of trading in the Shares of the Funds, which amendment will include reference to the fifteen Funds described herein. The Trust filed an Amended Application for an Order under Section 6(c) of the 1940 Act for exemptions from various provisions of the 1940 Act and rules thereunder (File No. 812-14405), dated September 21, 2015 ("Exemptive Application"). The Shares will not be listed on the Exchange until an order ("Exemptive Order") under the 1940 Act has been issued by the Commission with respect to the Exemptive Application. Investments made by the Funds will comply with the conditions set forth in the Exemptive Order. The description of the operation of the Trust and the Funds herein is based, in part, on the Registration Statement and the Exemptive Application.”

The Exchange believes that the proposed rule change, as modified by this amendment, is consistent with the requirement of Section 6(b)(5) of the Securities Exchange Act of 1934<sup>1</sup> (“Act”) that an exchange have rules that are designed, among other things, to prevent fraudulent and manipulative acts and practices, to promote just and equitable principles of trade, to remove impediments to, and perfect the mechanism of a free and open market and, in general to protect investors and the public interest. The Exchange is correcting the citations to the Trust’s Form N-1A and Exemptive Application, which were misstated in the Filing.

All other representations in the Filing remain as stated therein and no other changes are being made.
