SR-NYSEArca-2017-07; Partial Amendment No. 3

NYSE Arca, Inc. (“NYSE Arca” or the “Exchange”) hereby amends SR-NYSEArca-2017-07, Amendment No. 1 (the “Filing”) as follows:

1. The Exchange proposes to add the following sentence to the end of the first full paragraph on page 11 of the Form 19b-4 and the third full paragraph on page 30 of the Exhibit 1 of the Filing under the “Availability of Information” heading:

“The Benchmark will be disseminated by one or more major market data vendors every 15 seconds during the NYSE Arca Core Trading Session of 9:30 a.m. to 4:00 p.m. E.T.”

All other representations in the Filing remain unchanged as stated therein and no other changes are being made.
