SR-NYSEArca-2019-38--Partial Amendment 2

NYSE Arca, Inc. (the “Exchange”) hereby amends SR-NYSEArca-2019-38 (the “Filing”) as follows:

1. The first paragraph on page 7 of the Filing and the last paragraph on page 32 extending to the top of page 33 of Exhibit 1 to the Filing are deleted and replaced with the following:

“The Fund may hold the following U.S. and non-U.S. exchange-listed and over-the-counter (“OTC”) derivative instruments: OTC foreign currency forwards; U.S. and non-U.S. exchange-listed futures and options on stocks, Fixed Income Securities, interest rates, credit, currencies, commodities or indices on the foregoing securities and financial instruments; and OTC options on stocks, Fixed Income Securities, interest rates, credit, currencies, commodities, or indices on the foregoing securities and financial instruments.^{12,}”

2. The fifth sentence on page 22 of the Filing and the fourth complete sentence on page 55 of Exhibit 1 to the Filing are deleted and replaced with the following:

“In addition, the Exchange may obtain information regarding trading in the Shares, ETFs, certain exchange-traded options and certain futures from such markets and other entities that are members of the ISG, or with which the Exchange has in place a comprehensive surveillance sharing agreement.”

All other representations in the Filing remain unchanged as stated therein and no other changes are being made.
