**SR-NYSEMKT-2016-102; Partial Amendment No. 1**

NYSE MKT LLC on behalf of NYSE Amex Options (“NYSE Amex Options” or the “Exchange”) hereby amends SR-NYSEMKT-2016-102 (the “Filing”) as follows:

1. The Exchange proposes to replace footnote 10 on page 5 of the Form 19b-4 and footnote 9 on page 10 of Exhibit 1 of the Filing with the following:

“ATP Holders would be required to provide all the essential information regarding paired orders when sending it to NYSE OptX, including the price of the option and the stock, the size and side of the order, i.e., buy or sell, and delta. The Exchange represents that QCC Orders sent to the Exchange for execution would comply with the order format and EOC entry requirements established by the Exchange. See Rule 955NY – Order Format and System Entry Requirements.”

All other representations in the Filing remain unchanged as stated therein and no other changes are being made.
