**Partial Amendment No. 2 to SR-PHLX-2020-41**

At this time, Nasdaq PHLX LLC (“Phlx”) hereby submits this Partial Amendment No. 2 to SR-PHLX-2020-41. Specifically, Phlx proposes to partially amend the Amendment No. 1 to SR-PHLX-2020-41 to remove the words “non-public” from the rule text on page 20 of the 19b4 and page 43 of the Exhibit 1. As proposed, the first sentence on page 20 of the 19b4 and page 43 of the Exhibit 1, under the heading “Annual Report,” would state, “The Exchange would provide to the Commission an annual report each year for 5 years on the anniversary of the first day of trading of VOLQ options.”
