22 **[PROPOSED] ORDER APPROVING THE DISBURSEMENT OF FUNDS FOR**  
23 **DISTRIBUTION TO HARMED INVESTORS BY THE DISTRIBUTION AGENT**

24 This matter is before the Court on Plaintiff’s Unopposed Motion to enter an Order to  
25 disburse \$45,932,699.22 by the Distribution Agent, Rust Consulting, Inc., to the 99,820  
26 Eligible Claimants as provided for in the Distribution Plan (“Plan”) (D.E. 490), including those  
27 Eligible Claimants that clear the Specially Designated Nationals (“SDN”) list published by the


1 Office of Foreign Assets Control.<sup>1</sup> Having considered the Motion and the record and being  
2 otherwise fully advised in the premises, for good cause shown the Motion is **GRANTED**.

3  
4 The Court **HEREBY ORDERS AND ADJUDGES** as follows:

5 The Distribution Agent, Rust Consulting, Inc., shall disburse \$45,932,699.22 in distribution  
6 payments to 99,820 Eligible Claimants as provided for in the Plan of Distribution, including  
7 distribution payments to those Eligible Claimants that clear the SDN list.
