
1 This matter is before the Court on Plaintiff’s Unopposed Motion to
2 Approve a Supplemental Disbursement of Fair Fund for Distribution to Harmed
3 Investors By the Distribution Agent in the amount of \$31,066.25 to compensate
4 those as yet unpaid Eligible Investors on the Final Payee List, including those
5 Eligible Investors that have cleared the Specially Designated Nationals (“SDN”)
6 list published by the Office of Foreign Assets Control.¹ Having considered the
7 Motion and the record and being otherwise fully advised in the premises, for
8 good cause shown the Motion is **GRANTED**.

9 The Court **HEREBY ORDERS AND ADJUDGES** as follows:

10 The Distribution Agent, Rust Consulting, Inc., shall disburse \$31,066.25 in
11 distribution payments to the remaining unpaid Eligible Investors as provided for in
12 the Plan of Distribution, including distribution payments to those unpaid Eligible
13 Investors that have cleared the SDN list.
