NOTICE IS HEREBY GIVEN that the Distribution Agent's Motion

1 for orders approving his final report on claims, distribution plan,
2 payment of fees and expenses and for other relief, was heard by the
3 Honorable Alicemarie H. Stotler, Judge Presiding, on the above
4 noted date, place and approximate time. The Court granted the
5 motion and entered its Order on January 22, 2007, ratifying,
6 approving and confirming the Distribution Agent's report, account
7 and administration of the estate, and further directing and
8 authorizing the distribution agent to take reasonable and necessary
9 actions to complete the administration and distribution of the
10 assets of American Medical Products, Inc. The Court approved six
11 (6) late filed claims in the interests of Justice. The financial
12 impact is a reduction of \$231.42 per \$10,000.00 claim as presented
13 in the Notice of Hearing previously mailed.

15 sixty (60) days following the mailing of this Notice of Ruling and
