That is the last day by which a claim may be filed. Any claim filed subsequently will be subject to denial and nonpayment in any amount.

ADDITIONAL FORMS ARE AVAILABLE AT THE RECEIVER'S OFFICE. **YOU ARE REQUIRED TO FILE TIMELY A PROOF OF CLAIM IF YOU SEEK RECOVERY ON YOUR CLAIM.**

CONSENT TO JURISDICTION OF THE COURT

By filing a proof of claim with the Receiver, you agree that the Court shall have jurisdiction over all claims identified in your proof of claim ("Claims") and over all aspects of your Claims, including but not limited to the amount of your Claims, the priority in distribution of your Claims, the determination of allowance of your Claims, and the scheduling and allocation of the funds available to satisfy your Claims (if any are available), and that objections or disputes thereto shall be submitted to the Court upon motion practice for hearing and a final ruling thereon. The matter shall be heard by the Court without a jury.
