Notice of an application under section 6(c) of the Investment Company Act of 1940 (the "Act") for an exemption from sections 18(a)(2), 18(c) and 18(i) of the Act and for an order pursuant to section 17(d) of the Act and rule 17d-1 under the Act.

<u>Summary of Application</u>: Applicants request an order to permit certain registered closed-end investment companies to issue multiple classes of shares of beneficial interest with varying sales loads and to impose asset-based distribution and/or service fees.

<u>Applicants</u>: Constitution Capital Private Markets Fund, LLC (the "Initial Fund"), and Constitution Capital PM, LP (the "Adviser").

Filing Dates: The application was filed on July 12, 2022, and amended on September 19, 2022. Hearing or Notification of Hearing: An order granting the requested relief will be issued unless the Commission orders a hearing.
