## ORDER DENYING REQUEST FOR ORAL ARGUMENT

John M.E. Saad has applied for review of FINRA disciplinary action. In connection with that application, Saad has requested oral argument. Commission Rule of Practice 451(a) provides that oral argument will be allowed in a case of this type only if the "Commission determines that the presentation of facts and legal arguments in the briefs and record and the decisional process would be significantly aided by oral argument." It appears that the issues raised in the pending application can be determined on the basis of the record and the papers filed by the parties, without oral argument.<sup>2</sup>

Accordingly, it is ORDERED that the request of John M.E. Saad for oral argument is denied.
