Self-Regulatory Organizations; MIAX PEARL, LLC; Notice of Withdrawal of Proposed Rule Change to Amend the MIAX PEARL Options Fee Schedule to Remove Certain Credits

On September 1, 2022, MIAX PEARL, LLC (“MIAX Pearl”) filed with the Securities and Exchange Commission (“Commission”), pursuant to Section 19(b)(1) of the Securities Exchange Act of 1934<sup>1</sup> and Rule 19b-4 thereunder,<sup>2</sup> a proposed rule change to remove certain credits. The proposed rule change was published for comment in the Federal Register on September 20, 2022.<sup>3</sup>

On October 25, 2022, MIAX Pearl withdrew the proposed rule change (SR-PEARL-2022-35).
